
Unemployment rate - 12.7% Unemployment rate 65 + - 3.3%


Important steps in developing an aging policy

- 2007 Georgia has become a member of the UNECE Working Group on Ageing
- 2015 Developed a roadmap to the mainstreaming of aging with the support of the UNECE
- 2015 Established Intersectoral Working Group
- 2016 Parliament adopted the concept of state policy on population aging in Georgia
- 2017 The Government approved the 2017-2018 National Action Plan on the State Policy on Population Aging in Georgia



Priorities of National Action Plan 2017-2018

- 1. The mainstream of aging
- 2. Integration of older citizens into society
- 3. Perceptions of older people and coverage by the media
- 4. Providing adequate social protection for the elderly
- 5. Utilization of the employment potential of the elderly
- 6. Lifelong learning
- 7. Health and welfare of the elderly
- 8. Mainstreaming the Gender Approach
- 9. Intergenerational Solidarity
- 10. Migration
- 11. Integration in international processes
- 12. research and data collection
- 13. Monitoring and evaluation





National Action Plan on Ageing 2017-2018

- In accordance with the priorities of the strategy Madrid International Plan of Action on Ageing (MIPAA) and Regional Implementation Strategy (RIS)
- 13 Priorities and Goals
- 29 Tasks
- 65 Activities
 - 32 fully completed
 - 9 partially completed
 - 24 not performed







Accumulated pension scheme

- 2018 Law of Georgia on Accumulated Pension
- 2018 Pension Agency created
- 2019 Accumulated pension scheme comes into force
- Pension contribution 2% + 2% + 2%
- Participation in the pension scheme
 - Obligatory All employed, who were not yet 40 years old by August 6, 2018
 - Voluntary:
 - For all self-employed, regardless of their age;
 - For all employees who were 40 or more years old on August 6, 2018.





Social Protection (1)

- Switch from a medical model to disability to a social model
 - The tools needed to implement the biopsychosocial model have been developed
 - Piloting started in Adjara
- Develop community-based services tailored to the needs of the elderly
 - Work on community service standards is underway
 - 11 Community Organizations: Tbilisi, Ozurgeti, Signagi, Kareli, Lagodekhi, Rustavi, Gori, Telavi, Gurjaani, Kvareli, Sagarejo -300 Beneficiaries



Social Protection (2)

- Develop the concept of long-term care
 - The term "long-term care" is interpreted in the law
 - A long-term care standard has been prepared
 - 2020 Funding for Family (6 Beneficiaries) and Shelters (24 Beneficiaries) Services to Increase
- Home Care
 - 2016 Home care standards is develop
 - Home care services were introduced in Tbilisi





Health and welfare of the elderly

- State Universal Health Program
- Chronic diseases drugs program
- Rural doctor / ambulance care program
- Referral service program
- Screening programs
- •
- Compulsory module of social gerontology and geriatrics integrated into the curricula of physicians and midwives





Utilization of the employment potential of the elderly

- 30% of teachers employed in vocational development schools are of retirement age
- Vocational Training-retraining program 128 seniors
- Prof. Counseling 277, Internship 10,
- Intermediary Services 80,
- Supportive employment 5
- People were employed 262
- In the framework of the program "Teach for Georgia" includes 9 retirement teachers





Awareness Raising and Volunteering

- Raising Awareness of the Law on Volunteering among the Elderly
 - 2015 Law of Georgia on Volunteering
 - Young volunteers hold information meetings with the Elderly in 64 Municipalities
 - Young volunteers actively work in homes for the elderly
- Raising public awareness of aging issues
 - 27 meetings in 19 municipalities
 - TV and radio shows
 - Booklets and Triplets
 - Lectures and seminars



Prevention and response mechanisms for violence against the elderly

- Law of Georgia on the Prevention Violence against Women or Domestic Violence, Protection and Assistance to Victims of Violence (2006)
- 2016, the program "Health Response to Domestic Violence / Gender-Based Violence" has been implemented by support of UNFPA
- Launch awareness-raising campaign against violence, including for the elderly
- Support services for victims of violence have been developed
