What did the Project achieve during the reporting period? Please, describe your achievements, which should be in line with Project goal and objectives.

The project was implemented in accordance with the planned activities. 2 kick-off meetings were held with the Project staff and involved participants from the regions. At these meetings, the following were outcomes developed:

General Project Workplan and individual Workplans of staff. Core key Project results for the reporting period:

• Emergency needs assessment was carried out, which resulted in the Report "Impact of Coronavirus and its implications on the livelihoods of 350 elderly people in the Kyrgyz Republic", with assessment-based conclusions and recommendations. (Annex 1)

• 12 Memorandums were concluded, including 1 memorandum with the Ministry of Health and Social Development, 4 with territorial health care institutions and 7 with local government bodies.

• 5 online meetings of the Health Club were held, with participation of members of the international Agenet International network, members of SHGs, SCCs, Council of Paramedics, aimed at continuous learning and best practices exchange for COVID-19emergency response:

- June. Presentation "Live and Move on the Bright Side" was made by Akhmetzhanova Bayan (Astana), Director of "Ardager" NGO and Agenet International network member.
- July. Presentation "Supporting health and physical activity of the elderly: experience of the "University of the Golden Age" (Grodno, Belarus). The speaker of the meeting was Lana Rudnik, Director of the private institution "Center for Continuing Education for Adults" Studio of Useful Competencies", Co-founder and Director of the "University of the Golden Age" program.
- September. Presentation "Dementia: Early diagnosis, prevention, care. Improving quality of social services for people with Dementia". Speaker was Amankanova Salima (Red Crescent Kyrgyzstan), partner, member of the AgeNet International Network.

- October. Presentation "Post-Covid Syndrome. How Coronavirus affects mental health." Speaker: Galina Tsepkovskaya, SHG Coordinator, representative of ADRA Kyrgyzstan, Psychiatrist.
- November. Presentation "Stress Prevention". Speaker: Amerkhanova Saniya, Practicing psychologist, acting Associate Professor of the Institute of Continuous & Distant Education (IC&DE) at the Bishkek State University named after K.Karasaev.
- November. Presentation "Movement is life!". Speaker: Marina Zelyenaya, external expert from Belarus.
- 3 meetings of the Leaders' Club were held:
- On July 1, the following issues were discussed on the Agenda: (1) Discussion of the current situation with Elderly People (EP). Vaccination. (2) Presentation of the WHO Project. (3) Planning the "Health Club" meetings schedule and topics. (4) Participation in the workshop on national priorities and policy in the field of population aging achievements and failures: Kyrgyzstan.
- On September 10, the following issues were discussed: (1) Discussion of celebration of the Day of the Elderly in the Bishkek Social Hospital Institution (SHI) for the elderly and people with disabilities September 30. (2) Proposals for Celebrating the Elderly Day from the Network members for October 1. (3) Informing about "Health Clubs" held online.
- On October 12, the following issues were discussed: (1) Results of the month celebration, timed to coincide with the International Day of Elderly People partners; (2) Discussion of holding the Conference on Aging of the AgeNet RCE; Presentation was made on implementation of the Action Plan on improvement of quality of life of senior citizens in the Kyrgyz Republic for 2019-2025, dated August 30, 2019 No. 442 MOH&SD of the Kyrgyz Republic. The "Leaders' Club" meeting was also attended by Swiss Red Cross experts, who want to get acquainted with the Age Net network activities and members.
- Internet platform <u>http://agenet.org.kg/</u> was developed and launched.

• Training and involvement of the elderly people was carried out as part of training on network literacy and information search, including medical information. This training improved knowledge level of participants on the network literacy of older people, as well as Internet use to search for medical and other useful information, creating accounts in social media and creating publications/posts. At the training, the participants were introduced to the Internet using computational tools, search, editing and use of information. All participants created email and social media accounts. Skills in letter writing and social networking were improved. The second part of the training was devoted to the online platform, all participants successfully registered in it. The trainer demonstrated how to run the platform using Internet services and connected devices.

• Online training was conducted on the topic: "Coronavirus infection vaccination". The speaker was: Kyrgyzbaev Azim, Doctor and epidemiologist of the Republican Center for Immunoprophylaxis, MOH. Participants were provided with information on the following topics: (1) Information on COVID-19 vaccines, (2) Vaccination of the elderly. Characteristics of vaccines, (3) Organization and delivery of vaccines. Services of health care institutions for vaccination of the elderly. The event was attended by 98 participants: representatives of SHGs, SCCs, Council of Paramedics, representatives of territorial Social Protection departments, Heads of the SHIs, social workers, etc.

- The Council of Paramedics was created, with the meetings held:
 - **First online meeting** was held on June 23rd. The following issues were considered on the Agenda: (1) Election of the Council of Paramedics Chairman; (2) Suggestions for the Work plan for the Paramedics Council; (3) Diabetes Mellitus- how to use glucometer. Following the meeting, the following decisions were made: (1) all regional leaders to conclude Memorandums with local self-government bodies to track data on COVID-19; (2) Develop the work plan for the Council; (3) Compile the database on the EP' problems in each region; (4) Conduct blood sugar screening among the EP; (5) Inform EP and promote vaccination; (6) Hold meetings of the Council once a month; (7) L.E.Belikova from Kara-Balta City was elected as the Council Chairwoman.
 - Second meeting was held on July 30 in Balykchy City with the following Agenda issues: (1) Situation with vaccination in each region, presentation from each Council member for their region; (2) Monitoring of EP with medical contraindication to vaccination; (3) Informing EP in their SHGs about new COVID-19 strains and prevention; (5) Planning the Council's actions for the current months.
 - **Third meeting** was held on 16 September with the following issues on the Agenda: (1) Discussion of the situation with vaccination in the regions. (2) Interaction with the media in the regions on COVID-19 prevention and vaccination at the places of residence. (3) Conducting the survey among the elderly SHGs

about theirs needs in autumn and winter periods. (4) Tracking of the elderly with high blood sugar? (5) Active rest of the SHG.

Fourth meeting was held on 18 October with the following issues on the Agenda: (1) Situation with COVID-19 patients. (2) Interaction with the media in the regions on COVID-19 prevention and vaccination at the places of residence. (3) Implementation of the events dedicated to the International Day of the Elderly. (4) Prevention of Diabetes Mellitus among the EP.

• The expert of the Resource Center for the Elderly carried out review of the KR Law "On Senior Citizens in the Kyrgyz Republic", as a result of which consultations were held with representatives of civil society and senior citizens in Osh and Bishkek cities. The consultations made it possible to engage the elderly people in discussions of the issues related to them and their health and ensure their participation; more than 50 people took part in two consultations. The meeting was held in Q&A format, during which the participants were able to discuss the conclusions and recommendations obtained from the review of the KR Law "On Senior Citizens in the Kyrgyz Republic". Public consultations of the human rights expertise of the law of the KR Law were organized with the support of the UNHCHR for Central Asia in partnership with the NGO "Resource Center for the Elderly". Based on the discussion, expertise of the KR Law was forwarded to the KR Ministry of Justice.

- Direct Project beneficiaries:
 - The database of the elderly for 7 Project regions has the data for 11950 EP.
 - Screening for blood sugar was carried out in 9136 EP.
 - Through 2 Project trainings: 119 EP and representatives of social sphere were trained.
 - Health club: 50 members, Leaders club: 15 members.
 - Participants of the month, dedicated to the International Day of Older Persons: 500 (100 in Balykchy City, 350 in 7 regions, 50 in Bishkek SHI).
 - 3000 protective masks were produced and distributed.
 - Social media coverage: 36 598.

• Awareness and ability of older people to protect themselves from viral infections, including COVID-19, are continuously raised through the website, social media pages, Whatsup groups, YouTube channel. Regular website updates. The following information products were distributed during the reporting period,:

- information posters from WHO.

During the event, medical boxes were distributed to the SHI clients.

• The following support was provided to the elderly during the Project life:

• During the Project, the leaders of SHGs/SCCs actively interacted with local self-government bodies to monitor and track older people vaccinated or infected with coronavirus. 21 meetings were held.

• During the reporting period, 28 SHG/SCC meetings were held, with participation of 336 elderly people. The main topics of the meetings: help and information about Diabetes Mellitus and Coronavirus.

• 202 elderly people were trained at the cascade trainings.

• On November 24, the final online Conference "Towards Healthy Aging" was held under the Project. The Conference was attended by 140 people. Welcoming remarks were made by Cholumova Nazgul, Head of the department for development of social services for people with disabilities and senior citizens, KR Ministry of Labor, Welfare & Migration and Artykova Nazira, WHR and Head of WHO CO in Kyrgyzstan. Representatives of the Resource Center for the Elderly shared the results of the activities of the Project "Strengthening the participation

of civil society in the response to COVID-19 at the national and local levels". The participants got acquainted with the activities and the first results of the Council of Paramedics activity, which was created to assess the COVID-19 situation and its impact on the elderly in the regions of the country, and carried out the work in the regions to prevent Coronavirus infection and raise awareness among the senior citizens. Borombaeva Toktokan, involved expert, informed the participants on the results of the survey "Impact of Coronavirus and its Consequences on the Livelihoods of Elderly People in the Kyrgyz Republic". This survey was initiated by the RCE aims to identify the basic needs and requirements of EP during the COVID-19 pandemic, as well as to develop recommendations for the authorized bodies to respond to the basic PE needs. Aidaralieva Gulzada, Chief Specialist of the Department for Development of Services for PWDs and Senior Citizens, KR MOLW&M, informed the participants about interaction in the regions in the context of the pandemic and as part of implementation of the Action Plan to improve the quality of life of the elderly. The participants were informed about the implementation of the Action Plan on improving the quality of EP life. Baktygul Ismailova, Chief specialist of the KR MOH Public Health Department, spoke about access of EP to health services and vaccination, as well as COVID-19 incidence among the EP. Since 2006, free health care has been provided to retirees aged 75 and over under the State Benefits Program, since 2008 – to the EP at the age of 70 +, for other retirees co-payment for inpatient treatment has been reduced to the minimum (330 - 360 Soms). Currently, in order to conduct mass vaccination, 868 temporary vaccination sites have been created during the mass vaccination with additional 123 sites later. EP at the 60+ age are at risk and should be vaccinated as a priority. The current challenge is the lack of awareness of citizens of this age category about the need for vaccination and location of vaccination points. Distrust of the elderly in this procedure represents an important factor, which reduces efficiency of population vaccination. According to the RCE data as of November 24, 2021, the contingent of citizens at the 60+ age (559 701 people) was vaccinated by 53,5%. Of them, 161 842 people (28,9%) got the I-st dose, 136 793 people (24,6%) - the II-nd dose of vaccine. During the discussion, the participants noted the need for further work in the regions aimed at raising awareness of EP on prevention of Coronavirus infection, vaccination, exchange of experience and development of active longevity. Recommendations and proposals, generated through the Conference, aimed at improving the situation of EP in the Kyrgyz Republic, will be forwarded to the relevant Ministries and Agencies.

• Work and participation in development of the program document on Active Longevity continues to include the needs of EP in the COVID-19 epidemic context into the National Action Plan to improve the quality of EP life in the Kyrgyz Republic for 2019-2025. To date, this issue has reached the government level and is being discussed when developing the Action Plan of the KR Cabinet of Ministers until 2026.



- Together with WHO and "OSSE" Optics CO, 300 elderly people were checked by ophthalmologists.
- 3000 facial protective masks produced and distributed.

- It is necessary to continue the topic of studying and preventing infection. The government employees at sites lack knowledge and sufficient information to transfer. People in the regions have little understanding of the importance of vaccination.
- It is necessary to continue supporting and developing the Council of Paramedics as a volunteer structure to provide support to EP as liaison between health care institutions and EP.
- It is necessary to improve the capacity of the seniors through trainings and platforms on active longevity, access to health services, vaccinations, prevention of NCDs and Coronavirus infection.
- The population does not realize the importance of the aging problem. It is necessary to promote active longevity and active aging among the seniors.
- Elderly members of migrant families are in a very vulnerable position, most of them quite often look after the minor children. It is necessary to develop a plan of joint actions to provide them with social and other support.
- It is necessary to develop the Advocacy Plan in each region of the Project to form the basis of the Roadmap "Healthy Aging in Kyrgyzstan".
- It would be very useful to establish and train Volunteer Rescue Squads for emergencies response.
- It would be good to develop and publish together with the authorized body the Guidelines on the Best Practices based on the generated experience of working with the elderly,
